## **Public health attestation**

I, the undersigned, certify that the live fish and gametes described in Part I were produced in accordance with these requirements, in particular that they:

1. live fish and gametes subjected to treatment, destined for human consumption and exported to Tajikistan were produced in establishments/farms, approved by the Competent Veterinary Service in the IRAN for supplying their production for export and operating under its constant supervision.

2. live fish and gametes originate from establishments/farms which have not been placed under animal health restrictions.

3. live fish and gametes were examined by an Official of the Competent Authority of the country for presence of helminths, bacteriological and viral infections by methods, which are used in the IRAN (in accordance with WOAH regulations).

4.According to the Chapter 4.4. of WOAH Code – 2021 ,all the salmonid eggs disinfected not later than 48 hours before embarkation using an iodophore solution containing 100 ppm available iodine for a minimum of 10 minutes . No preservative or any other unapproved substances (Included but not limited to Malachite green) used on during eggs production.

5. Eyed eggs hibernated in insulated box on trays with ice each bag containing only one species. The bags placed within polystyrene boxes or cartons fitted with a plastic lining.

6. Means of transport are treated and prepared in accordance with the rules approved in the IRAN.
